## Summary for Quarterly April to June 2024:

The second quarter of 2024 has been a period of notable achievements for PPHI Sindh, underscoring its commitment to enhancing healthcare services and infrastructure across the province. This summary highlights key initiatives and accomplishments in various areas, reflecting PPHI Sindh's multi-faceted approach to public health improvement.

### Infrastructure Enhancements:

• **Laboratory Services:** The inauguration of a state-of-the-art laboratory in Larkana has significantly enhanced diagnostic capabilities, allowing for more accurate and timely medical analysis.

• **Medicine Management:** The establishment of a new medicine warehouse at MCHC Kausar Hospital, Khairpur, has streamlined the supply chain, ensuring adherence to SOPs for essential medicines and reducing stock-outs.

### Healthcare Utilization:

• **Outpatient Department (OPD):** The quarter saw a robust utilization of OPD services, with a total of 10.28 million visits, comprising 6.51 million new cases and 3.78 million follow-up cases. This high patient turnout reflects the trust in PPHI Sindh's healthcare services.

• **Maternal Health Services:** A significant focus on maternal health led to

87,669 deliveries, including 83,762 normal vaginal deliveries and 3,851 caesarean sections. Additionally, 193,444 Antenatal Care-1 (ANC-1) visits were conducted, underscoring PPHI Sindh's commitment to maternal and child health.

• **Family Planning Initiatives:** PPHI Sindh's family planning efforts included the distribution of 38,546 Postpartum Family Planning (PPFP) commodities and the administration of 49,701 Long-Acting Reversible Contraceptives (LARC), promoting informed family planning decisions.

### Disease Control and Prevention:

• **Tuberculosis (TB) Control:** Through extensive screening, 228,456 TB suspects were examined, resulting in the identification and management of 2,435 positive cases, thereby enhancing TB control efforts in the region.

• **Hepatitis Control:** A comprehensive hepatitis screening and vaccination drive led to 1.1 million screenings and the administration of 1.06 million doses. The positivity rates were recorded at 5% for Hepatitis-C and 1% for Hepatitis-B, indicating a proactive approach in combating these diseases.

### Nutrition and Health Promotion:

• **Management of Acute Malnutrition:** The Nutrition program admitted 20,550 children for treatment across 950 OTP sites, with an additional 996 children receiving care at 17 Nutrition Stabilization Centers

(NSCs).

• **Health Facility Monitoring:** PPHI Sindh conducted 23,396 visits and 613 monitoring calls to health facilities, ensuring the maintenance of high standards in healthcare delivery and addressing any service gaps. nutrition care.

### Capacity Building and Training:

• PPHI Sindh facilitated 98 training sessions, reaching 1,706 participants. These sessions covered a range of essential topics, equipping healthcare professionals with the necessary skills to deliver quality care. These initiatives highlight PPHI Sindh's holistic approach to healthcare, combining infrastructure development, service delivery, disease control, and community engagement. The organization remains committed to improving healthcare access and quality, ensuring a healthier future for the people of Sindh.

## Activities & Events (Head Office)



In a significant move to eradicate polio from the region, medical and public health students will actively participate in the upcoming polio campaign. This decision was made in a recent high-profile meeting chaired by the Minister for Health and Population Welfare, Dr. Azra Pechuho and Chief Secretary Sindh, Syed Asif Haider Shah. The meeting was also attended by PPHI Sindh CEO, Mr. Javed Ali Jagirani.



The Chief Minister Sindh, Syed Murad Ali Shah met with a delegation of the World Bank led by its Country Director, Mr. Najj Benhassihne, where the focus was on addressing critical environmental drivers of stunting in the province. The meeting, also attended by the CEO PPHI Sindh, Mr. Javed Ali Jagirani and other key stakeholders, underscored the importance of water, sanitation, hygiene, and the agri-food system in combating child stunting.



The newly established CEMonC services including C-Section services at Rural Health Centre (RHC) Daur were launched during a notable ceremony along with the unveiling of a new ambulance by the esteemed Dr. Azra Fazal Pechuho, Minister of Health and Population Welfare Department, Government of Sindh, and the CEO of PPHI Sindh, Mr. Javed Ali Jagirani, alongside Regional Director of RO SBA, Dr. Zuhaib Islam Abbasi.

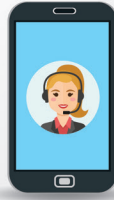
