The third quarter of 2023 was marked by remarkable advancements in the health-care endeavors of PPHI Sindh, underscoring the organization's unwavering commitment to improving public health and well-being in the region. This period was characterized by several noteworthy developments that reflect the organization's dedication to enhancing health-care services and making a positive impact on the communities it serves.

One of the notable achievements during this quarter was the inauguration of a state-of-the-art laboratory in Larkana, further bolstering the diagnostic capabilities of PPHI Sindh. Additionally, a new medicine warehouse was opened at MCHC Kausar Hospital Khairpur, emphasizing the organization's commitment to ensuring strict adherence to Standard Operating Procedures (SOPs) and the proper placement of essential medicines.

In terms of healthcare service utilization, the quarter witnessed significant engagement:

**OPD Visits and New Cases:** A substantial 11.5 million Outpatient Department (OPD) visits were recorded during this period. Among these, 7.5 million were new cases, and 4 million were follow-up cases, highlighting the extensive reach and effectiveness of PPHI Sindh's primary healthcare services.

**Deliveries and Maternal Health:** The organization proudly facilitated 101,795 deliveries, including 4,493 Cesarean sections (CS), ensuring the safe arrival of newborns into the world. Further, there were 186,491 Antenatal Care-1 (ANC-1) visits and 528,514 ANC-1 revisit cases, underlining the focus on maternal health and prenatal care.

Family Planning Services: Family Planning (FP) services played a crucial role during the quarter, with 261,114 FP visits recorded. The consumption of

short-acting reversible contraceptives included 78,611 Oral Contraceptive Pills (OCPs) and 114,392 injectables were administered, and that of long-acting reversible contraceptives included 28,389 Intrauterine Contraceptive Devices (IUCDs), and 19,204 implants, promoting family planning and reproductive health.

#### Hepatitis Screening and Vaccination:

The efforts to combat hepatitis showed significant progress, with 715,380 Hepatitis-C screenings and 715,431 Hepatitis-B tests conducted with a positivity rate of 5% and 2%, respectively. Furthermore, a total of 1.2 million doses of the Hepatitis vaccine were administered, contributing to a healthier population.

**Nutrition Services:** The Accelerated Action Plan (AAP) continued its mission to combat child malnutrition through 950 Outpatient Therapeutic Program (OTP) sites across 23 districts. During this quarter, 11,386 children were admitted for treatment, and their successful recovery, transfers, and exits were documented, addressing a pressing health concern.

#### **Nutrition Stabilization Centers (NSCs):**

These specialized facilities played a pivotal role in addressing severe malnutrition cases complicated by medical issues. A total of 3,372 children were admitted in 17 NSCs operating in 13 districts with successful recoveries, medical transfers, and exits, emphasizing the organization's holistic approach to nutrition care, during the quarter.

Health Facility Monitoring & Tele-Monitoring: The organization demonstrated its commitment to quality healthcare by making a total of 21,809 visits to HFs to assess the standard and quality of the infrastructure and services and 174 calls to monitor health facilities, effectively supervising and assessing 174 facilities across different regions.

**EPI and UC Categories:** Immunization efforts were meticulously outlined by district and Union Council (UC) categories, showcasing substantial progress in vaccination coverage and ensuring that children received essential immunizations.

Capacity Building: In the realm of Capacity Building and Training, the third quarter of 2023 witnessed a remarkable commitment to enhancing knowledge and skills, with a total of 45 comprehensive training sessions conducted. These training initiatives were designed to empower and upskill a total of 1,059 participants, equipping them with the tools and expertise needed to excel in their respective roles.

In essence, this comprehensive summary underscores the substantial accomplishments and diverse healthcare services provided by PPHI Sindh during the third quarter of 2023. The organization's multifaceted efforts spanned a wide spectrum of healthcare domains, from maternal health and family planning to nutrition stabilization and educational sessions, ultimately contributing to the improved health and well-being of the communities served.

# BREAKING BARRIERS (Refusal Village Shah Hassan's Journey to Immunization)

In the remote village of Shah Hassan and its parts Pir Mashak/sher-badshah & Madni Mallah, located in UC Chinni, Taluka Johi, a transformative medical camp took place on the 26<sup>th</sup> of October, 2023. This remarkable event was an orchestrated effort, led by dedicated healthcare professionals, to address vaccine refusal among children. The camp involved the Medical Officers, Female Medical Officers, Community Midwives (CMW), Dispensers, Lab Technicians, Vaccinators, and Nutrition Assistants, all of whom were unwavering in their commitment to public health. With the invaluable support of the District Manager PPHI Dadu, this camp aimed to reverse the growing trend of vaccine hesitancy among the local population at village Shah Hassan UC Chinni Taluka Johi District Dadu.

#### The Confluence of Healthcare Professionals

A team of healthcare professionals converged in Shah Hassan Village, bringing with them their expertise and compassion. This ensemble included Medical Officers, Female Medical Officers, CMWs, Dispensers, Lab Technicians, Vaccinators, and Nutrition Assistants. They were the frontline workers, the heroes of this story, who ventured to overcome the challenge of vaccine refusal and ensure routine immunization for every child in need.

#### **District-Wide Support**

The importance of community health was underscored by the support of the District Manager PPHI Sindh District Dadu Their unwavering dedication to public health and well-being made this camp possible. It is a testament to the collaborative spirit that drives such critical initiatives.

#### **Supervision and Quality Control**

The camp attracted the attention of not only local health-care professionals but also District Monitors, including the District Manager. District Coordinator EPI PPHI, Executive M&E and TSVs Taluka Johi also visited the camp. Their presence provided critical oversight and ensured the quality of healthcare services & Routine Immunization.

#### **Achieving Success Against Refusal**

The primary objective of the camp was to address vaccine refusal among children and ensure that they received the necessary immunizations. The camp achieved remarkable success:

BCG	17 children who had previously refused the BCG vaccine received it.
OPV-0	O2 children who had previously refused the Oral Polio Vaccine (OPV) received their first dose.
Penta-1	04 children who had previously refused the Pentavalent vaccine (Penta-1) received it.
Penta-2	12 children who had previously refused the second dose of the Pentavalent vaccine (Penta-2) received it.
Penta-3	03 children who had previously refused the third dose of the Pentavalent vaccine (Penta-3) received it.
Measles-1	04 children who had previously refused the first dose of the Measles vaccine (Measles-1) received it.
Measles-2	02 children who had previously refused the second dose of the Measles vaccine (Measles-2) received it.
MR Additional Dose	A significant milestone was achieved when 36 children received the additional dose of Measles-Rubella (MR) vaccine.

Total OPD	The camp provided overall medical services to 204 individuals who sought medical assistance.

#### Conclusion

The medical camp held in Shah Hassan Village on the 26<sup>th</sup> of October, 2023, is a testament to the dedication and unwavering commitment of healthcare professionals in addressing vaccine refusal. It is also a shining example of the collaborative effort of the District Manager PPHI Dadu and a dedicated team of district monitors and supervisors.

The successful coverage of previously refused vaccinations, including BCG, OPV-0, Penta-1, Penta-2, Penta-3, Measles-1, Measles-2, and MR Additional Dose, is a heartwarming achievement in the ongoing battle for public health. This initiative serves as a reminder that when communities and healthcare providers work hand in hand, seemingly insurmountable challenges can be overcome, ensuring a healthier and safer future for all.










## Success Stories of Nutrition

The child was enrolled in OTP program, in the criteria of SAM with generalized wasted muscles and prominent ribs. She was lethargic at the time of admission with poor hygiene, her nails were not trimmed and she was not bathed for 3 days. Nutrition Assistant counseled the mother regarding and hygiene and hand washing practices and NA also encourage her to take proper care of her child. The mother followed the instructions of NA and finally the health of child got improved from these followings.






#### Amna D/O Sahab Dino

Age (8 Months) | Duration (2 Months)
BHU Fazal Sahito, Nowsheroferoze

Child was identified SAM while screening, Baby was referred from NSC. Baby was weak and Nutrition Assistant gave session to his Mother about IYCF, Nutrition and Health hygiene principles. Mother has less knowledge of proper breastfeeding. The staff from BHU educate her mother regarding the proper positioning of breastfeeding and also discussed key messages of RUTF and its usage. Baby Health improve gradually by following the instructions of Nutrition Assistant and now finally baby was cured from OTP.

Madhu was referred from OPD referral and access by PPHI Sindh Nutrition Assistant on outreach activities at OTP site. The child got admission to the program. When the beneficiary arrived at the CMAM site, her parents were unaware of hygienic protocols and food practices, but after counselling by the nutrition assistant, her mother agreed to follow the instructions given by NA, and NA noticed that the mother was interested in bringing her child on a regular follow ups, and finally, she was discharged as per the matched exit criteria.

This child is classified in severe acute malnutrition (SAM) and was admitted in OTP program when beneficiary came at OTP site, his parents has less knowledge about the proper hygiene and health protocols, NA guided the family and after admission to the OTP site the health of the beneficiary got drastically be improved after eating RUTF and the parents appreciated the efforts of PPHI OTP site RHC TANGWANI District Kashmore @ Kandhkot staff.
