- Sealed Technical and Financial proposal should be delivered at PPHI Head Office up to 27th January, 2020 by 1:00 pm. Technical Proposal will be opened on the same day at 3:00 pm in presence of authorized representatives who wish to attend.
- In case of bid submitting /opening day is declared holiday, the same will be submitted/opened on the next working day.
- 4. The tenders will not be issued to those firms which are black listed by PPHI Sindh or any Government department/agency/body/ or have defaulted in execution of PPHI Scheme(s).
- 5. The Bidders shall have Valid PEC Registration in Category C-6 & above.
- The Bidders shall have at least last three years (36 months) bank statement showing minimum 3.0 Million annual turnover.
- 7. The Method of Procurement will be Single Stage Two Envelopes.
 - a) Bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal.
 - b) Envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion (Mandatory).
 - c) Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened.
 - d) Envelope marked as FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened.
 - e) Procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform the specified requirements.
 - f) No amendments in the technical proposal shall be permitted during the technical evaluation.
 - g) Financial proposals of technically qualified bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
 - h) Financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders; and
 - i) The bids found to be the lowest shall be accepted.

The Procuring Agency reserves the right to reject any or all bids and may cancel the bidding process at any time prior to the acceptance of a bid as per rules.
