Terms & Condition

1. Under following condition bid will be rejected
2. Conditional and telegraphic bid/ tenders
3. Bids no accompanied by call deposit of required amount and form
4. Bids received after specified date and time
5. The tenders will be not issued those firms which are Black listed / defaulter incomplection of the previous schemes awarded
6. Bid validity period 30 days
7. Procuring agency reserve the right to reject all or any bids for sufficient and cogent reasons which will be communicated to the bidder on request
8. Responsive bidder is required to submit following documents with their applications
 - i. List of similar assignments with similar cost under taken over the past three years
 - ii. Details of equipment, machineries and transport owned by firm/contractor
 - iii. Turnover of at least three years
 - iv. Financial statement (summary) and income tax return for the last one year



- v. Registration with sindh revenue board
- vi. Affidavit that firm has never been black listed / documents submitted are original and correct
9. Contractors are advised to quote their rates on percentage basis above /below on the schedule “**B**” items / and quote their own rates on non schedule items
10. The work calculation/RCE may vary by (+) or (-) 10%
11. Interested firms/Government Contractors may obtain the tender documents for above works along with complete detail of scope of work from the PPHI Head Office by submitting application on letter head along with tender fee through pay order (non-refundable) in the name of **BHU Repair & Maintenance PPHI** and call deposit of 2% of the cost from the date of publication of NIT in the daily news paper up to closing date of the tenders.
12. Call deposit 2% of the cost through payorder Region Hyderabad in the name of “**PPHI R&R Tender Schemes**”
